4(1)(b)(i) The Particulars of its organization, function and duties:-

'West Bengal Health Recruitment Board' has been constituted by Health & Family Welfare Department Notification No. HF/O/GA/2378/2E-04/11 Pt. II dated Aug 1, 2012 for direct Recruitment of different type of Posts (119 in No.) of Health & Family Welfare Department delinking the same from Public Service Commission, West Bengal vide Finance Department Memo No. 4969 F (P) dated the 20th June, 2013.

The West Bengal Health Recruitment Board (WBHRB) is responsible for selecting and recommending candidates for direct recruitment to posts permanent or temporary for which the appointing authority is the Government in the Department of Health & Family Welfare and authority subordinate to the Governor excepting those cadre posts of the Secretariat of the Health & Family Welfare Department & the Directorate for which the cadre control authorities are the Departments other than the Health & Family Welfare Departments.

Functions and Duties

- 1. To conduct examinations mainly for recruitment to the different categories of posts of the Health & Family Welfare Department, West Bengal Government and .
- 2. Forward to the appointing authority, on the basis of the results, the names and other details of the candidates recommended for the vacancies reported.

4(1)(b)(ii) Power and duties of its officers and employees.

Powers and duties of its officers and employees are fixed on the basis of guidelines as laid down in West Bengal Secretariat Manual, West Bengal Service Rules, Part-I, West Bengal Service (Classification, Control and Appeal) Rules, 1971 and important circulars as issued by the Government from time to time etc.
