There was an interim order, dated: 14.06.2022 of the Hon'ble West Bengal Administrative Tribunal in connection with O.A. No. 355 of 2022, Anindita Sarkar & Ors. – vs - The State of West Bengal & Ors. to allow ANINDITA SARKAR, DIBYENDU KHAN, KALLOL BHOWMICK and BRAJA GOPAL JANA to appear for the selection process for the post of Dental Technician/Dental Mechanic, Gr-III, which is to be held on 15th June, 2022 or any subsequent date without prejudice to the rights and contentions of the parties and subject to further orders that may be passed. It was also directed that the results of the applicants will not be published without the leave of the tribunal and the answer scripts and the mark sheets of the applicants will be kept in a sealed cover. In terms of aforesaid order, the applicants, who had been originally rejected by the Technical Experts were allowed to appear before the interview Board on 06.07.2022 and the Interview Score Sheets of the applicants were kept in a sealed cover. It may be mentioned that as per terms and conditions laid down in the advertisement as stated above, WBHRB did not conduct any written examinations for recruitment to this particular post. Subsequently, by an order dated 10.11.2022, Hon'ble West Bengal Administrative Tribunal directed that the "respondents is at liberty to publish the result of the written examination". It is to be noted here neither in the order dated 14.06.2022 nor in the order dated 10.11.2022 passed by the Hon'ble W.B.A.T. there is any comment/direction from the Hon'ble W.B.A.T. regarding eligibility of the applicants for which they were rejected by the Technical Experts as valid applicant. Hence, in compliance with the order dated 10.11.2022 the name of the above mentioned applicants are furnished below with their interview marks only.
