1. In continuation of This Office earlier Interview Notice No. 2285/HFW-53024/30/2022-HRB Dated 10.11.2022, the interview of few eligible candidates in the following cases for the post of Homoeopathic Pharmacist [Advertisement Number: <u>R/HP/19/2022 DATED 19-04-2022</u>] will be held on 22.12.2022.

Case: 1- Candidates, Who have failed to attend on the scheduled date of Interview and submitted written prayers for fixing an alternative date of interview and whose prayer have subsequently been accepted by Board.

Case: 2- Candidates whose payment status were originally shown as pending and who, in pursuance of Notice vide Memo No. 2123/HFW-53024/30/2022-HRB Dated 29.09.2022 have informed WBHRB about the problem in the official e mail ID of WBHRB, along with copy of the GRIPS challan between 11.10.2022 to 13.10.2022 (5:30 pm).

- 2. The Reporting time and date of interview of the candidate for the above mentioned post will be as per call letter. Candidates are instructed to report on time. Candidate will not be allowed to enter at the scheduled venue mentioned in the call letter if reported after one hour of the scheduled reporting time.
- 3. Candidates should bring two copies of complete set of call letter at the time of reporting for interview. Kindly note that no candidate shall be permitted in the Examination centre without carrying print out of Call Letter and ID proof (in original)
- 4. Candidates must have spoken and written knowledge in Bengali.
- 5. Original and two complete sets of self-attested photocopies of Registration Certificate as Homoeopathic Pharmacist under West Bengal Council of Homoeopathic Medicine must be produced & submitted at the time of interview mandatorily(applicable for the post of Homoeopathic Pharmacist only).
- Candidates are requested to bring blue/black ball point pen. 6.
- 7. Mobile phone, Laptop, Scanner, camera etc. are not allowed at the venue for interview.
- 8. No TA/DA will be admissible.
- 9. Due to Covid-19 Pandemic situation candidates are requested to wear mask mandatorily. No entry will be allowed without wearing mask in proper way.
