<u>WHEREAS</u> the category wise panel and overall performance of all eligible candidates, including those who are selected in the panel for the post of Dental Technician/Dental Mechanic, Grade-III, [Advt. No. R/Dental Tech./Dental Mech., Grade-III/17/2021, modified Advt. of R/Dental Tech./Dental Mech., Grade-III/10/2021] were published in the website of West Bengal Health Recruitment Board vide Memo No.556/HFW-53099/28/2022-HRB dated 24.03.2023.

AND

<u>WHEREAS</u> after publication of the same West Bengal Health Recruitment Board has received one original application bearing O.A. No. 207 of 2023 filed by the applicants namely Anindita Sarkar & Ors. before the Hon'ble W.B.A.T. wherein it has been alleged that one applicant namely Prosenjit Bala has been selected although his qualification is equivalent to the qualifications obtained by the applicants.

AND

<u>WHEREAS</u> the applicants were rejected by the technical experts on the ground that they have not fulfilled the eligibility criteria as prescribed in the advertisement itself.

AND

<u>WHEREAS</u> after receiving such complaint as mentioned in the original application being O.A. No. 207 of 2023, West Bengal Health Recruitment Board decided to have the opinion of the concerned Technical Expert who were involved in checking the essential qualification of the applicants as well as Prosenjit Bala.

AND

WHEREAS the aforesaid Technical Experts have submitted a report from which it appears that the application of PROSENJIT BALA, ANINDITA SARKAR, DIBYENDU KHAN, KALLOL BHOWMICK and BRAJA GOPAL JANA were rejected by the concerned Technical Experts as all of them have produced Mark Sheet for Dental Mechanics Certificate Course but the essential qualification as per advertisement was Two Years Diploma in Dental Technician. However, one Technical Expert who had subsequently accepted the Essential Qualification of PROSENJIT BALA, for which PROSENJIT BALA was called for the interview, has now submitted that the Essential Qualification of PROSENJIT BALA was mistakenly accepted due to human error which was un-intentional. It has also been stated in that report that Certificate Course cannot be approved as per advertisement.

<u>AND</u>

<u>WHEREAS</u> the matter was placed to the meeting of the Board held on 06.04.2023 and the Board has decided that the candidature of PROSENJIT BALA, may be rejected, on the basis of the report of the Technical Expert.

Now, considering the aforesaid matter and the decision taken by the Board Meeting of West Bengal Health Recruitment Board, the candidature of Sri Prosenjit Bala, whose name was published in Sr. No. 1 of Panel List (Scheduled Caste), vide Memo No. 556/HFW-53099/28/2022-HRB dated 24.03.2023 is now rejected.
